\$100.00 Refundable Cleaning/Damage Deposit. If the Theater is not cleaned after your event, a cleaning fee will be taken out of your deposit check with the remaining balance returned to you.

You will not be allowed to use the Boys & Girls Clubs of Mason Valley logo or brand name in any type of marketing or advertising.

You are allowed to only use our address of: 11 N. Main Street.

Any violation of this request will result in your event being cancelled and your \$100.00 deposit being forfeited to the Yerington Movie House.

All cleaning and damage deposits are due at the signing of this agreement. All deposits for rentals will be deposited by the Yerington Movie House. After inspection of the facility by Yerington Movie House staff and its determined that the facility is clean to our standards and nothing has been damaged a check will be issued to the renter within 15 days.

Set up for all events will need to take place in adherence to any current showtimes unless authorized to do otherwise.
